CBE Student Survey Data:

- 85% of Grade 4 & 5 students reported positive relationships at school
- 73% of Grade 6 9 students reported positive relationships at school
- 90% of students report they have enough technology to support their learning
- 98% of students use technology to help them learn
- 84% of students treat people with the same respect online as they would face to face
- 33% of students report they trust information they find online
- 70% of students use information online and know how to note where the information comes from in their work
