3. **Additions and Approval of Agenda:** Motioned by Ally W. seconded by Scott F.; all in favour and agenda passed with the addition of the funding request.
4. **Reading and Approval of Minutes from October:** Motioned by Ally W., seconded by Scott F. ; all in favour and minutes approved.
5. **Parent Council representative Reports:**
 - 5.i **RSA report** – Christine M. reported that the RSA has a bank balance of \$48,111.18. There remains \$9,999.88 available after all approved spending requests cheques have been issued. As part of the AGLC requirement all funds must be used within 36 months of receipt. To date the RSA has \$38,974.88 remaining from the casino (Oct 2021) that is required to be spent by October 2024. And \$8,909.80 remaining from the WestJet raffle (March 2023) that is required to be spent by March 2026.
 - 5.ii **Volunteer Committee chair:** – Scott previously updated in Parent Council meeting.
 - 5.iii **Grade 0 Sailing Committee Chair** – Rhonda P. upcoming December movie night sell treats and Harvest dinner, Purdie's chocolates. Updated on the outcome of the previous fundraisers.
 - 5.iv **Casino Chair** – Angela Ng casino update; casino is done for the year. It was a success but a few volunteer positions were not filled. Angela has been doing this role for over 4 years

and is ready to step down. Money should be deposited in February and we may get up to \$75-\$80K.

5.v **Fundraiser update**; currently we are running a plant sale, as well, some fundraisers are on the website such as Mable's Labels, Neily's, and True Earth we get 20% of sales the link to these fundraisers are on website. There is also a link on the website that will direct people to Education Matters where they can donate directly to the school. The Harvest Dinner in February is planning on also having a silent auction.

6. **New Business Funding Request:**

- 6.1.1 Funding request of \$500 by Jeff Krar for science/math for school design tools and supplies. Ally W. motioned for RSA to fund the request, seconded by Scott. All approved and motion passed.
- 6.1.2 Funding request of \$500 by Jeff Krar for card games and board games for the Career Technology Foundations class. Ally W. motioned for RSA to fund request and seconded by Scott F.. All approved and motion passed.
- 6.1.3 Funding request of \$2,275 by Susan F for 60 ipad cases/protectors. Request was discussed and parent council will look into finding better priced option and if found will purchase and donate to the school.
